RENEWED WRIT OF BODILY ATTACHMENT

THIS CAUSE came before this Court on June 20, 2019 on a Hearing on Plaintiff's Ex-Parte Motion for Writ of Attachment for failure to comply with this Court's Order dated January 22, 2018 of which Defendants were noticed and served. Plaintiffs appeared for this Hearing but Defendants did not appear. This Court has reviewed the court file and is otherwise fully advised in the premises. Based on the foregoing, it is

ORDERED and ADJUDGED as follows:

1. This Court finds that Defendant, Christopher Chestnut, is in willful contempt of court for failure to comply with this Court's Order on Contempt and Sanctions dated January 22, 2018. The following facts support a finding of Contempt:

- a) Christopher Chestnut willfully failed to respond to or provide all documents responsive to Plaintiffs' Request for Production in Aid of Execution and answers to Plaintiffs' Interrogatories in Aid of Execution.


- b) Christopher Chestnut has not satisfied the underlying judgment in this matter.
- c) Christopher Chestnut has not fully disclosed all assets, including but not limited to, prior cases in progress and referral of same to other attorneys.

2. This Court orders that the Sheriff take the Defendant Christopher Chestnut into custody, if found in the State of Florida.

3. This Court further orders that the Sheriff hold Defendant, Christopher Chestnut, in safe keeping and produce Defendant before a first appearance judge within 24 hours of Defendant's detention, so that the first appearance judge may order the Martin County Sheriff's Office to produce Defendant to this Court on the following business day or, if the following business day is a Saturday, Sunday or legal holiday, on the next business day following, whereby Defendant shall be provided an opportunity to comply with this Court's Order of Contempt and Sanctions dated January 22, 2018 and other purge himself of Contempt.

4. This Court further orders that the Martin County Sheriff's Office shall notify this Court of the Defendant's detention and the execution of this Writ no later than 4:00 pm the day after the Defendant is first detained, or if the day of initial detention is a Saturday, Sunday or a legal holiday, on the next business day following.
